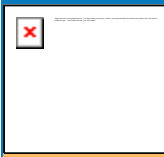

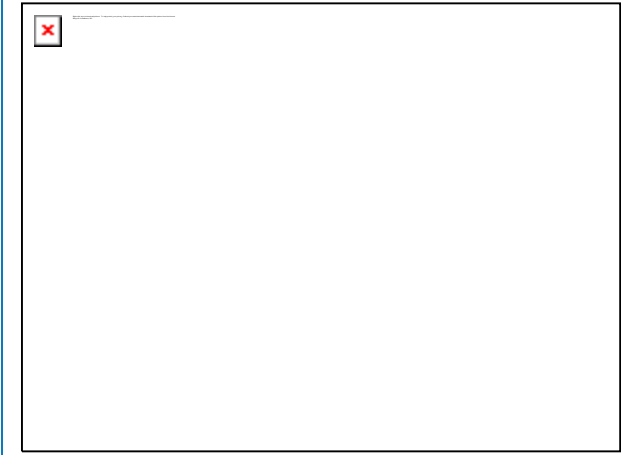
This looks like another FOIA. How much money are they spending on this? I looks like pure propaganda to me.

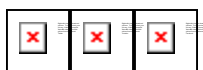
