

World AIDS Day



Our Bureau of International Labor Affairs (ILAB) has received more than \$46 million to establish HIV/AIDS workplace education programs in more than 30 countries. To date, these efforts have reached more than 3 million workers.

In the U.S., an Occupational Safety and Health Administration (OSHA) standard – detailing what employers must do to protect workers in contact with infectious materials in blood – has safeguarded 5.6 million workers in healthcare and related industries.







KNOCK OUT THE FLU BUG!


- Use a tissue or your elbow, not your hand, to cover your nose and mouth when coughing or sneezing!
